This security audit deal started in July and ended in October.

I. How it Happened

The execution happened in three stages over a period of 25 days.

i. Vulnerability Scanning

Ravi S. had full confidence on S ubhash and sent him to Noida during D iwali to do the a udit. S ubhash f ound m any s ecurity loopholes in their network including application, O S, A V, Router and Firewall. This took 10 days.

ii. Vulnerability Fixing

Arpan he lped S ubhash f ix t he v ulnerabilities l ike ba ck door Trojans, Spyware, OS patches, Antivirus, Routers and Firewall. This took an additional 10 days.

iii. Vulnerability Rescanning

As a way to establish credibility with the customer, Subhash did vulnerability r escanning of c omplete ne twork t o find out whether the ne twork is secure or not. He found the ne twork fully secured. This took another 5 days.

iv. Report Submission

Next came report submission, which was also an uphill task as the client was little insecure and impatient. Things became easy with the help of I mam, Niranjan, R avi C houdari, A rup a nd Satish who worked continuously for 4 days, including overnight shifts, a nd s ubmitted t he 1000 page report in a compressed timeframe.
